a pushbutton dial surface for a telephone set base, the surface being very slightly curved and having a plurality of rectangular buttons arranged in rows and columns to a left hand side of the surface, a plurality of triangular buttons arranged in a column spaced from and parallel to the columns of rectangular buttons, and parallel lines extending across the surface the width of the surface, the lines positioned above and below the top and bottom rows of pushbuttons and between the rows of pushbuttons, the lines also extending above, below and between the triangular buttons.

Figure 1 is a perspective view of the dial surface for a telephone set base.

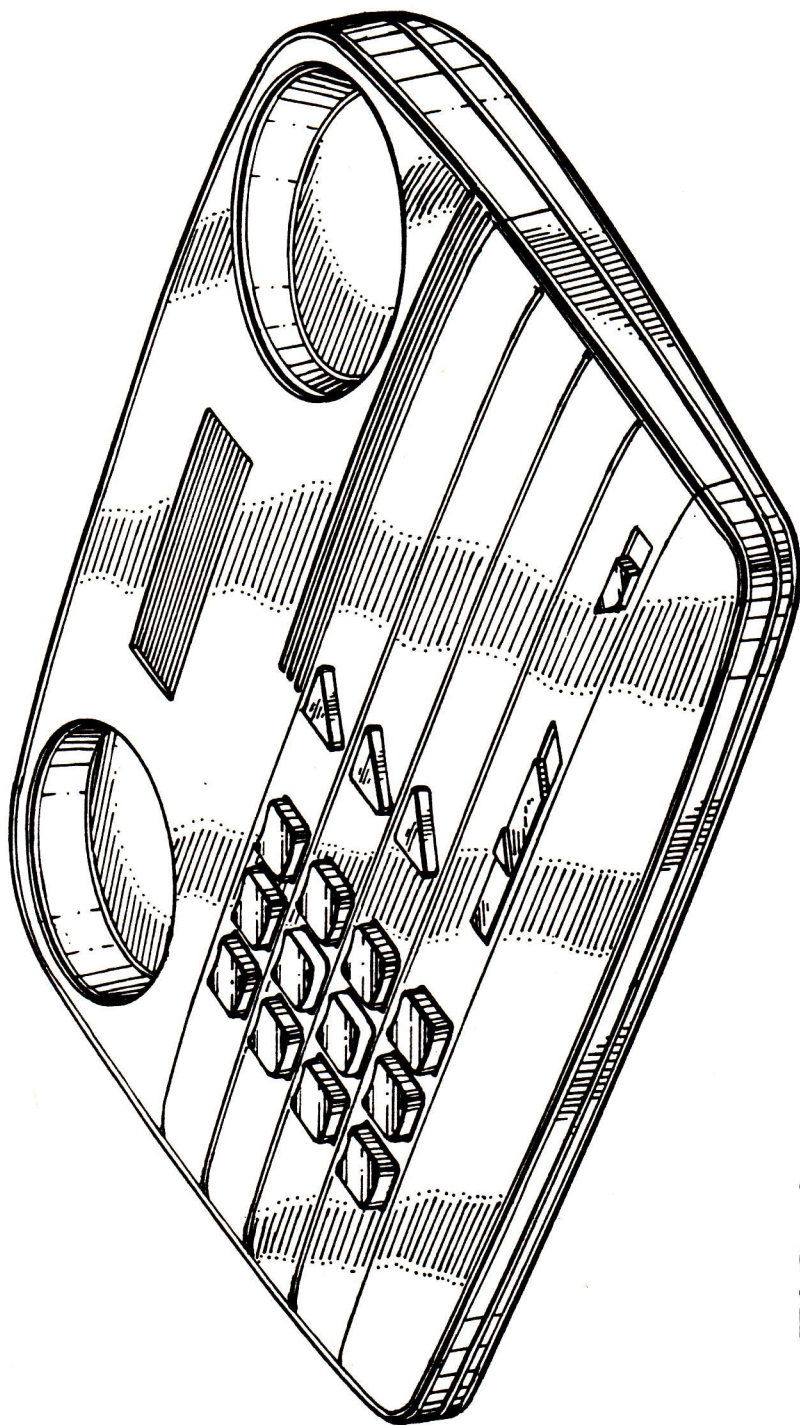
